



**How to become a Republican election delegate or alternate (2-year term) and the responsibilities in an election year 2026. (even years).**

1. Attend your local Republican county precinct caucus on 02/03/2026 and sign up to be a delegate or alternate. You can also submit amendments to change the state platform of the Republican Party of Minnesota at the caucus and vote to move to county **BPOU** convention.
2. Attend your local Republican county **BPOU** convention held on 03/07/2026 and get elected by giving a one minute speech as to why you are committed to serving. Important points are that you will show up to all conventions, you will research candidates, you are a Republican and you will support the endorsed candidates. Once you are elected you can vote to endorse candidates for local and state offices, and advance changes to the state platform.
3. Attend the **CD7** convention on 04/25/2026 and vote to endorse candidates for **CD7** and make changes to the **CD7** platform.
4. Attend the Minnesota state convention on 05/30/2026 and vote to endorse state candidates and make changes to the state Republican platform.

**Responsibilities of an elected delegate and alternate in a non-election year 2027. (Odd years).**

1. Attend your county **BPOU** convention. Elect **BPOU** executive committee (Chair, Deputy Chair, Secretary, Treasurer, and up to 12-Vice Chairs). Elect 2-State Central delegates and 4-alternates to represent your **BPOU** for the Minnesota Republican party. Vote on updates to the County **BPOU** constitution and bylaws.
2. Attend the **CD7** convention. Elect **CD7** executive committee, Chair, Deputy Chair, Secretary, Treasurer, State Executive, 6-Vice Chairs. Vote on changes to the **CD7** constitution and bylaws. It's easy! No monthly meetings to attend or committees to serve on. Just attend your caucus on a weeknight and 3-Saturday conventions in an election year. In a non-election year, attend just 2-Saturday conventions.



# Minnesota Congressional District Map




